The CSLA/AAPC College of Fellows A Brief History

The first Fellows were elected in 1964, followed by almost annual additions averaging three Fellows per year. By 1979, over 30 members had been honored by election to Fellowship and it was time to formalize the structure and process. At CSLA/AAPC Congress '79 in Charlottetown, the College of Fellows was established. Specific 'Rules for the Conduct of Operations' were adopted, outlining the structure and operation of the College and the guidelines for advancement of members to Fellowship.

The College's Executive Committee is responsible for the conduct of affairs, consisting of the Chair, Vice Chair, Secretary-Treasurer, and the President of the Landscape Architecture Canada Foundation (LACF), as well as the CSLA/AAPC President as ex-officio member. The Annual Meeting of the College is held each year in conjunction with the CSLA/AAPC Congress. An average of 20 Fellows have attended each AGM over the last several years.

Particular attention has been given to the manner in which new Fellows are admitted to the College and the role of the College in the larger activities of the profession and the Society. In accordance with the Rules for the Conduct of Operations, nominations to Fellowship may be presented to the College by the component organizations and/or the Board of Governors of CSLA/AAPC. The final selection is made by a Jury of Fellows, consisting of representatives from Canada's five regions (B.C., Prairie, Ontario, Quebec and Atlantic), who serve on the Jury for overlapping three-year terms. The Fellows-Elect are then ceremoniously inducted into the College during the banquet or other special event of the next CSLA/AAPC Congress.

Other activities of the College and its members involves assisting in the operation of the Accreditation Council, which administers the accreditation of Canadian schools/departments of landscape architecture since 1987, as well as the LACF. Since the Campaign of Fellows commenced in 1988, over \$415,000 have been donated by Fellows to the Foundation. These funds are used to promote the ideals of the profession

of landscape architecture through research and scholarship grants, firmly establishing the Foundation as a significant force in the future of the landscape architectural profession in Canada.

In recent years a special effort has been made to establish a profile record on each Fellow, in order to have such information available for present and future generations of landscape architects. To-date, these records are on file for 87% of the Fellows.

Since the inception of CSLA/AAPC, a total of 179 Fellows have been elected, 25 of whom are now deceased.

Criteria for Election to CSLA/AAPC Fellowship

Election to Fellow is the highest honour the CSLA/AAPC bestows on its members. Fellowship is the recognition of members who have made outstanding contributions to the profession over an extended period of time in one or more of the following categories:

- Executed Works of Landscape Architecture
- Administrative Professional Work in Public Agencies
- Professional University Instruction
- Professional Writing
- Service to the Community or the Public on behalf of the Society
- Direct Service to the Society

Other requirements for election are a minimum of twelve (12) years uninterrupted membership in the Society, strictly enforced confidentiality of nomination and a confirmative 75% majority vote by the Jury of Fellows. Outstanding contributions are generally considered to be contributions which are above and beyond those provided by a member of the profession. Particular attention is paid to those practitioners who have made nationally or internationally recognized contributions.

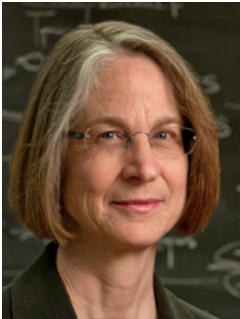
Penny Dunford

Ms Penny Dunford began her career in landscape architecture with a Diploma in Landscape Architectural Technology from the Northern Alberta Institute of Technology in 1976. Following that, she attended the University of Guelph and obtained a BLA degree in 1980. Penny became a member of the AALA in 1986 and has served on the executive as secretary and treasurer and has volunteered for many committees over the years. She has been chair of the AALA Exam Board since 2004. She became LEED accredited in 2004 and is an active member of the Alberta Low Impact Development Partnership and Alberta Green Building Council.

Penny began her professional career at EDA Collaborative, where she worked for twenty years on a wide variety of projects. In 2001, she joined Stantec Consulting in Edmonton where she is now practice leader of the Planning and Landscape Architecture group in Edmonton. She works closely with engineers, architects, and environmental scientists, promoting sustainable, landscape based solutions wherever possible. She has been a champion for the use of LID techniques and led the charge for the implementation of a number of LID features in a private subdivision development in Edmonton. This development helped influence the City to review design and construction standards with the goal of allowing and encouraging sustainable stormwater management. Penny also has a keen interest in trail development projects and spends her time outdoors whenever possible.

Cynthia Girling received her Bachelor's and Master's in Landscape Architecture from the University of Oregon in 1978 and 1980. She also holds a Bachelor of Environmental Studies from the University of Manitoba. She was accepted as a member of the BCSLA and CSLA in 1983 and has been a registered landscape architect in Oregon since 1996. She has served on the BCSLA Board of Directors while Chair of the Landscape Architecture Program, and has served on the Board of Examiners since 2005. At the national level, she was a juror for the CSLA awards in 2008, and is currently serving on the editorial board of Landscapes/Paysages. Cynthia is a Fellow past-President of the Council of Educators in Landscape Architecture and a former member of the Landscape Architect Registration Board in Oregon.

Cynthia is a Professor of Landscape Architecture in the School of Architecture and Landscape Architecture, University of British Columbia, and Chaired that program from 2004 to 2010. After practicing in Vancouver early in her career, she moved to academic practice and has now taught, conducted scholarship and headed landscape architecture programs for twenty-four years at the University of Oregon and now at UBC. Throughout her career, Cynthia has focused on the form-making role of open space in the city and in the environmental contributions of urban open space across several spatial scales — yards, neighborhoods, and open space systems. She has co-authored two books and numerous reports and articles. With Professor Ronald Kellett, she co-directs the elementsLAB, a research group who create tools and processes to assist communities with designing neighborhoods that are more energy conserving, lower environmental impact, of better design quality and more affordable.

Ms. Karen Le Gresley Hamre graduated from the University of Toronto with a BLA degree in 1979. She was accepted as a member of AALA in 1983 and was a founding member of the NWTALA, serving as the treasurer for the NWTALA since its inception. She served on the Gwich'in Land Use Planning Board from 1995 to 2004. During her time, the Planning Board finalized the only approved regional land use plan in the Northwest Territories.

Karen work in Germany after graduation, then in Ontario and Alberta in private and public sectors. In 1983, she moved to the Northwest Territories, working for the territorial government in parks and tourism positions. In 1985, she started Avens Associates Ltd., which she has owned and operated since then.

During her time in the north, Karen's work has ranged from private residences and municipal parks, through consultations for new Territorial parks and the aforementioned regional land use planning. Her work includes managing and co-ordinating various interdisciplinary teams. Most recently, she is Managing Director of the Northwest Territories Protected Areas Strategy, which bring together 14 organizations, including eight Aboriginal organizations, to the protect natural and cultural heritage of the NWT. She was the landscape architect for the first LEED certified building in the NWT, the Federal Greenstone Building in Yellowknife.

After graduating with a BLA from the University of Guelph in 1986, Myke began his career doing residential and housing projects independently. Though he tried his hand at many scales and types of projects, he enjoys working closely with clients and a small team to develop personal residential landscapes. Myke has directed Hodgins & Associés in Montreal since 1994. His firm has received many design awards, including a CSLA Award of Excellence, a winning design for the Botanical Gardens of Montreal and the firm has been featured in over a dozen articles in publications and a number of television programs. He has a skill with vegetation that takes years to develop and that most of us only wish we could equal. Though he has installed tens of thousands of plants, thousands of tons of stone, and dozens of swimming pools, Myke remains open to and eager for every new project, no matter what the scale.

Myke is committed to the promotion of landscape architecture and enjoys educating his clients on the subject. He also lectures on two different topics – landscape design principals and using colour outside - with the objective of increasing appreciation of landscape.

Working at both the provincial and national levels, Myke has made significant contributions to the profession of landscape architecture in Canada. He has participated in AAPQ committees since 1996, on the AAPQ Board since 1999, and the CSLA Board from 2000 to 2006. He was guest editor of *Landscape/Paysage* in 2007 "The Residential Landscape", served on the CSLA Awards Jury three times, led the re-design of *Landscape/Paysage*, sowed the seeds for our conferences in Cuba, Newfoundland and Nunavut, executed a publicity campaign that doubled the number of entries to the CSLA Awards Program and finally he worked to ensure the inclusion of a non landscape architect in the CSLA Awards Jury. As President of the CSLA from 2007 to 2008, Myke brought his vision of continuity and growth as well as a proactive team building approach to the organization. Continuing his service to our professional, Myke is currently a member of the Communications Committee for the Council of Landscape Architectural Registration Boards.

Après avoir obtenu un baccalauréat en architecture de paysage à l'université de Guelph en 1986, Myke entreprends sa carrière en réalisant des projets résidentiels comme travailleur autonome. Même s'il explore d'autres types de projet de différentes échelles au cours des ans, il préfère les projets qui se font en petites équipes et qui permettent des relations plus proches avec les clients. Myke dirige son propre bureau à Montréal, Hodgins et associés, depuis 1994. Récipiendaire de plusieurs prix, incluant un Certificat d'excellence de l'AAPC, ainsi que gagnant d'une compétition de design au Jardin Botanique de Montréal, son bureau s'est aussi illustré dans nombre d'articles et reportages.

Myke possède une profonde connaissance des végétaux, résultant de plusieurs années d'expérimentation, plusieurs lui en vient. Même s'il a déjà fait planter des millions de plantes, fait installer des tonnes de pierre et fait construire des dizaines de piscines au cours de sa carrière, Myke demeure animé d'un puissant désir de s'impliquer dans les nouveaux projets qui se présentent, peu importe leur échelle.

Myke s'implique dans la promotion de l'architecture de paysage et prend toujours un grand plaisir à partager ses connaissances avec ses clients. Il donne également des conférences sur deux sujets qu'il affectionne particulièrement, soit les principes de design du paysage et l'usage des couleurs à l'extérieur, avec l'objectif précis de susciter davantage d'intérêt chez les gens pour le paysage.

Actif tant au niveau provincial que national, Myke a contribué de façon significative à la profession de l'architecture de paysage au Canada. Depuis 1996, il a été membre de divers comités au sein de l'AAPQ. Depuis 1999, il siège au Conseil d'administration de l'AAPQ. De 2000 à 2006, il a fait parti du Conseil d'administration de l'AAPC. Il fut rédacteur invité à la revue *Landscape/Paysage* en 2007 pour le numéro "Aménagement résidentiel", il a siégé trois fois au jury pour les prix de l'AAPC, il a dirigé la nouvelle image de la revue *Landscape/Paysage*, il a tiré les ficelles pour permettre la tenue des conférences annuelles de l'association à Cuba, à Terre-Neuve et au Nunavut, il a géré une campagne publicitaire qui a permis de doubler le nombre de participations au programme des prix de l'AAPC et finalement, il a favorisé l'idée que siège un non-architecte-paysagiste au jury des prix d'excellence de l'AAPC. En tant que président de l'AAPC de 2007 à 2008, Myke a amené une vision de continuité et de croissance autant qu'une approche de travail d'équipe proactive. Toujours au service de la profession, Myke est maintenant membre du Council of Landscape Architectural Registration Boards.

Mr. Rob LeBlanc holds a B.Sc from Dalhousie University, a Bachelor of Design in Environmental Planning from NSCAD University and a Masters in Landscape Architecture from the University of Guelph. He has a certificate in golf course architecture from Harvard University. Rob is the past-president of APALA (2004-2006) and previously APALA's secretary treasurer for 6 years. He is a Member of the Canadian Institute of Planners (MCIP) and a Licensed Professional Planner (LPP). He is also a member of the Soil and Water Conservation Society (SWCS), the Canadian Green Building Council (LEED Green Associate) and the Canadian Landscape Reclamation Association (CLRA).

Since 1996, Rob has been the sole owner and senior principle of Ekistics Planning & Design and Form:Media in Dartmouth Nova Scotia. He oversees a staff off 20 design professionals ranging from landscape architects, planners, environmental designers, graphic designers and interpretive planners. The firm has an office in Halifax and Bangor Maine. He is also a senior Principle of LANDinc in Toronto and Abu-Dhabi. The firms work on a wide range of projects from waterfronts, parks, campuses, resorts and city designs around the world. In 1995, Rob spent a year as a design lecturer at the University of Canberra in Australia.

He has published in numerous refereed journals on stream and watershed bioengineering and ecological restoration. Mr. LeBlanc is particularly interested in the application of evolving technology to research and design and is involved in many projects, which require the careful balance of ecological preservation and development.

Ms Liane McKenna graduated from the University of Guelph in 1973 with a Bachelor's Degree in Landscape Architecture and the University of Victoria in 1998 with a Master of Arts Degree in Leisure Services Administration. She has been a member in the OALA, the AALA and most currently in 2003 BCSLA representing BCSLA on the CSLA Board from 2004 – 2008 .She was the Co Chair of the successful 2006 CSLA/CELA Conference in Vancouver, BC. She is a current member of the Accreditation Council and steered a project for the CSLA and the Landscape Architecture Canada Foundation in 2006 entitled "Strategy for Growth of the Landscape Architecture Profession". The membership elected her as CSLA President Elect in 2010 and she will begin her role as President at our Congress in Iqaluit.

Throughout her more than 30 year career, Liane McKenna focused on public practice, specifically Municipal Parks and Recreation. During the last 16 years she was Director of Parks and Recreation with the Vancouver Park Board, having previously worked for the cities of Calgary, Alberta and Scarborough, Ontario in similar capacities. Interests in environmental issues on public lands, expansion of park programming, and recent 2010 Winter Olympic community and facility development rounded out her career. Now retired she has moved to consulting practise.

Wendy Shearer has a B.A from Glendon College, York University, 1969 and a Bachelor of Landscape Architecture from the University of Guelph, 1981. She became a full member of the OALA in 1984. She has served on the Board of Directors of the Canadian Association of Heritage Professionals (formerly CAPHC) and the Alliance for Historic Landscape Preservation. She was co-chair of the ASLA Historic Preservation Group.

In 1984 she established Wendy Shearer Landscape Architect Limited and for 24 years provided landscape architecture and heritage consulting services on a wide range of projects.

In 2008 she joined MacNaughton Hermesen Britton Clarkson Planning Limited (MHBC) as Landscape Architect and Managing Director of Cultural Heritage to continue sharing her expertise with a broad range of public and private clients.

She was an adjunct professor at the University of Guelph from 1995 to 1999 and currently teaches the Cultural Landscape course at the University of Victoria in the Cultural Resource Management Program. Mr. Ian N.L. Wasson graduated from the University of British Columbia with a BA Double Major Political Science – History in 1985 and a BS Landscape Architecture (CSLA Award of Merit) in 1993. He was accepted as a member of BCSLA and CSLA in 1997. Ian served as BCSLA Registrar from 2000 to 2004 and while on the board chaired several BCSLA committees and acted as Secretary to the Board of Examiners. In 2004 Ian was elected as a Director to the Council of Landscape Architectural Registration Boards (CLARB) in Fairfax, VA, and elected subsequently as the first Canadian Secretary (2006), Vice-President (2008), President-Elect (2009) and President (2010 – present). During this period CLARB has newly defined areas of practice through its recent Welfare Study, worked with ASLA to create LACES, completed the most thorough Task Analysis to date, will publish the first Determinates of Success paper on emerging professionals and will have its first joint board meeting with La Sociedad de Arquitectos Paisajistas de México in Ensenada, Mexico.

Since 2002, Ian has been Urban Design Planner for the City Burnaby in British Columbia. In this position he is responsible for all aspects of planning, design, and construction of Burnaby's 135 km multi-modal urban trail network; Burnaby's streetscape programs; and the development of urban design policy, standards and details for the City's four rapidly developing Town Centres.
